



Workshop on Business and Human Rights in Africa: Advancing responsible business within an international context

CONCEPT NOTE & AGENDA

10 September 2024 (9am-5pm), UN House, Brussels, Belgium

Context and rationale

A decade after the adoption of the UN Guiding Principles on Business and Human Rights (UNGPs), the United Nations Working Group on Business and Human Rights (UN WGBHR) coordinated a series of efforts to take stock of the progress made, and produced a roadmap for the next decade, outlining the need to raise the ambition, increase the pace of implementation, improve coherence and create greater impact. The UNGPs are becoming better known and understood in Africa. Yet, awareness among all stakeholder groups and understanding of the expectations regarding States and businesses respective duties and responsibilities to protect and respect human rights require further strengthening. By undertaking the development of a regional policy on business and human rights (BHR) in 2018, the African Union sent a clear signal about its expectation from States, businesses and other actors that they work on the development of policies and frameworks conducive to responsible business practices and corporate accountability in the context of business activities on the continent. Some African governments have engaged in reforms to promote responsible business practices including developing National Action Plans on Business and Human Rights, improving the investment climate, strengthening corporate accountability and advancing sustainable development. An increasing number of stakeholders in the region have undertaken initiatives triggering an emerging movement in Africa. The establishment of the African Continental Free Trade Area (AfCFTA) offers a major vehicle for transforming the economies of African countries and where mainstreaming human rights will play a critical role in promoting inclusive and sustainable development.

Over recent years, countries across the world including the European Union (EU) have strengthened initiatives and regulations to promote responsible business conduct among business enterprises and their value chains. International standards on business and human rights, including the UNGPs, have played a predominant role in guiding the development of these recent policy and regulatory developments.

Recently adopted legislations include the EU Directive on Corporate Sustainability Due Diligence (CS3D), the German Act on Corporate Due Diligence Obligations in Supply Chains, France Corporate Duty of Vigilance, Norway Transparency Act and UK Modern Slavery Act amongst others that will affect economies beyond their countries, including businesses in Africa that have business relationships in these jurisdictions. In this context, achieving the interlinked global goals related to the climate emergency, the ongoing energy transition, inclusive economies and





sustainable development depends in large part on ensuring human rights are respected throughout business activities and supply chains - and the UNGPs is a foundational tool for that undertaking.

In this context, this workshop offers a timely opportunity to bring actors engaged in advancing business and human rights in Africa and in the EU into a constructive exchange to chart a constructive path forward. This event will be hosted by the UN Working Group on Business and Human Rights, the Office of the UN High Commissioner for Human Rights (OHCHR), in collaboration with the German Federal Ministry for Economic Cooperation and Development (BMZ) and the *Deutsche Gesellschaft für Internationale Zusammenarbeit* (GIZ). Examples from the BHR Africa project, implemented by the OHCHR with financial support from the GIZ on behalf of the BMZ, in four countries (Democratic Republic of the Congo, Liberia, Mozambique and Zambia) and four sub-regions of the continent, will inform the discussions.

Objectives

The workshop will aim to building strategic business and human rights engagement by:

- Facilitating exchange on recent regulatory and policy developments and exploring their potential implications as well as the challenges and opportunities that they present for advancing responsible business conduct;
- Informing the developments of strategic and effective engagements and collaborations, including education, capacity building, policy and regulatory initiatives;
- Strengthening collaboration, coherence and alignment of business and human rights engagement in the region;
- Foster engagement with the relevant UN human rights mechanisms and in particular the UN Working Group on Business and Human Rights.

Methodology and format

Participants will be invited to share their reflections and perspectives on the developments and actions needed to further promote responsible business conduct for sustainable development in Africa. This in-person workshop, designed to facilitate interactive discussions, will follow a plenary format throughout the day. It will be moderated by the hosts and selected participants.
